In exercise of the powers conferred by the proviso to Article 309 of the Constitution, read with Government of India, Ministry of External Affairs letter No. F.7(11)/62-Goa dated 25th July, 1963, the Administrator of Goa, Daman and Diu is pleased to make the following rules amending the Goa Government, Chief Electrical Engineer's Office Class I (Gazetted) posts Recruitment Rules, 1969 issued under Notification of even number dated 19th February, 1969 and published in Government Gazette Series I, No. 52 dated 27th March, 1969 namely:—

1. *Short Title and Commencement:* (i) These rules may be called Goa Government, Chief Electrical Engineer's Office Class I (Gazetted) posts Recruitment (First Amendment) Rules, 1970.

- (ii) They shall come into force at once.

2. In the Schedule attached to the said Notification, against the post of Executive Engineer appearing at serial No. 2, for the existing entry in column 11 substitute:

"Promotion:

- i) Assistant/Deputy Executive Engineer with five years service in the grade.
- ii) Assistant Engineer with eight years service in the grade.

Transfer on deputation:

Officers of the rank of Executive Engineer, failing which Assistant Executive Engineer with five years service as such, from Central/State Governments or Electricity Boards.

(Period of deputation ordinarily not exceeding three years)".

In exercise of the powers conferred by section 22 of the Goa, Daman and Diu Excise Duty Act, 1964 (5 of 1964) the Government of Goa, Daman and Diu hereby makes the twelfth amendment to the Goa,

Daman and Diu Excise Duty Rules, 1964 (hereinafter referred to as the principal rules) namely:—

1. Amendment of Rule 104 —

(i) After clause (2) of Rule 104 of the principal rules the following new clause shall be inserted as clause 2-A namely:

“(2-A)-The Commissioner may by way of transfer grant a licence for sale of liquor on the application of a person succeeding otherwise than by testamentary succession to the estate or any part of the estate of a person holding such a licence”.

(ii) After clause (3) of rules 104 of the principal rules, the following new clause shall be inserted, namely:—

“(4) The provisions of sub-rules (1) to (3) above shall mutatis mutandis apply to licences issued under rules 41, 43, 53 or 54”.

2. Amendment of rules 77.—In rule 77 of the principal rules:

(i) for the word ‘liquor’ the words ‘cashew juice or cashew apples’ shall be substituted;

(ii) between the words ‘cashew juice’ and ‘produced’ the words ‘or cashew apples’ shall be inserted.

3. Amendment of rule 90.—Clause (2) of rule 90 of the principal rules shall be substituted by the following, namely:

“(2) If the Commissioner on making such inquiry, as he thinks necessary, feels satisfied that there is no objection to the grant of a licence applied for under clause (1) above, he may issue the licence.

Provided that except in cases where the liquor is to be sold in hotels, restaurants or in packed bottles, licence for sale of liquor shall not be granted in respect of premises.

(i) Situated within a radius of 250 metres from a railway station including yard, workshop and locoshed belonging to the Railway Department.

(ii) Situated within a radius of 100 metres from any school, temple, permanent theatre or cinema house, childrens park, judicial court, military or police station or from any area where a factory as defined in the Factories Act, 1948 or a mine as defined under the Mines Act, 1962.

(iii) Situated within a radius of 500 metres from any licenced liquor shop.

(iv) In respect of which a substantial section of the population residing within a radius of 500 metres of such premises is, in the opinion of the Commissioner, opposed to the issue of licence.

Provided further that licence in respect of any existing liquor shop may be (a) transferred under sub-rule (2-A) of rule 104 (b) allowed to continue till the expiry of licence period and (c) renewed even though such shop is situated

within a prohibited radius in terms of the foregoing proviso.

In exercise of the powers conferred by section 30 of the Registration of Births and Deaths Act, 1969, the Administrator of Goa, Daman and Diu, with the approval of the Central Government, hereby makes the following rules namely: —

18 of 1969

1. Short title, extent and commencement. — (1) The rules may be called Goa, Daman and Diu Registration of Births and Deaths Rules, 1970.

(2) These rules extend to whole of the Union Territory of Goa, Daman and Diu.

(3) These rules shall come into force on 1-1-1971.

2. Definitions. — In these rules, unless the context otherwise requires —

(a) "Act" means the Registration of Births and Deaths Act, 1969;

(b) "Form" means a form appended to these rules; and

(c) "Section" means a section of the Act.

3. Period of gestation under Section 2(1)(g). — The period of gestation for the purposes of clause (g) of sub-section (1) of section 2 shall be twenty-eight weeks.

4. Submission of report under Section 4(4). — The report under sub-section (4) of section 4 shall be prepared in Form No. 1 and shall be submitted along with the statistical report referred to in sub-section (2) of Section 19, to the Administrator by the Chief Registrar every year by the 31st July of the year following the year to which the report relates.

5. Form, etc. for giving information of births and deaths under Section 8 and 9. — (1) The information required to be given to the Registrar under section 8, or, as the case may be, section 9, shall, if given in writing, be in Form Nos. 2, 3 and 4 for the registration of a birth, still birth and death respectively, and if given orally, mention the several particulars in the relevant Form.

(2) The information referred to in sub-rule (1) shall be given —

(a) in a municipality

(i) within seven days from the date of birth or still birth; and

(ii) within three days from the date of death;

(b) in any other area —

(i) within fourteen days from the date of birth or still birth; and

(ii) within seven days from the date of death.

6. Birth or death in a vehicle under section 8(1)(f). — (1) In respect of a birth or death in a moving vehicle, the person incharge of the vehicle shall give or cause to be given the information under sub-section (1) of section 8 at the first place of halt.

Explanation: For the purpose of this rule, the term "vehicle" means conveyance of any kind used on land, air or water and includes an aircraft, a boat, a ship, a railway carriage, a motor-car, a motor-cycle, a cart, a tonga and a rickshaw.

(2) In the case of deaths (not falling under clauses (a) to (e) of sub-section (1) of section (8) in which an inquest is held, the officer who conducts the inquest shall give or cause to be given the information under sub-section (1) of section 8.

7. Time and Form for notifying information under section 10(1). — (1) Every person required to notify a birth, still birth or death under section 10 shall give information thereof to the Registrar in Form Nos. 5, 6 or 7, as the case may be.

(2) Such information shall be given —

(a) in a municipality

(i) within fourteen days from the date of birth or still birth; and

(ii) within three days from the date of death

(b) in any other area —

(i) within fourteen days from the date of birth; or still birth, and

(ii) within seven days from the date of death.

8. Form of certificate under section 10(3). — The certificate as to the cause of death required under sub-section (3) of section 10 shall be issued in Form No. 8 and the Registrar shall, after making necessary entries in the register of births and deaths, forward all such certificates to the Chief Registrar or the officer specified by him in this behalf by the 10th of the month immediately following the month to which the certificates relate.

9. Extracts of registration entries to be given under section 12. — The extracts of particulars from the register relating to births or deaths to be given to an informant under section 12 shall be in Form No. 9 or Form No. 10, as the case may be.

10. Authority for delayed registration and fee payable thereof under section 13. — (1) Any birth or death of which information is given to the Registrar after the expiry of the period specified in rule 5, but within thirty days of its occurrence, shall be registered on payment of a late fee of rupee one.

(2) Any birth or death of which information is given to the Registrar after thirty days, but within one year of its occurrence, shall be registered only with the written permission of the officer prescribed in this behalf and on payment of a late fee of rupees three and production of an affidavit made before a notary public or any other officer authorised in this behalf.

(3) Any birth or death which has not been registered within one year, of its occurrence, shall be registered only on an order of a Magistrate of the first class or a Presidency Magistrate and on payment of a late fee of rupees five.

11. Period for the purpose of Section 14. — (1) Where the birth of any child had been registered without a name, the parent or guardian of such child shall within 12 months from the date of regis-

tration of the birth of child, give information regarding the name of the child to the Registrar either orally or in writing.

Provided that if any such information is given after the period of 12 months, subject to the provisions of sub-section (4) of section 23, the Registrar shall,

(a) if the register is in his possession, forthwith enter the name in the register on payment of a late fee of rupees two.

(b) if the register is not in his possession and if the information is given orally, make a report giving necessary particulars, and if the information is given in writing, forward the same to the officer specified by the Administrator in this behalf for making the necessary entry on payment of a late fee of rupees two.

(2) The parent or the guardian as the case may be shall also present to the Registrar the copy of the extract given to him under section 12 or a certified extract issued to him under section 17, and on such presentation the Registrar shall make the necessary endorsement relating to the name of the child or take action as laid down in clause (b) of the proviso to sub-rule (1).

12. Correction or cancellation of entry in the register of births and deaths under Section 15.—(1) If it is reported to the Registrar that a clerical or formal error has been made in the register or if such error is otherwise noticed by him and if the register is in his possession, the Registrar shall enquire into the matter and if he is satisfied that any such error has been made, he shall correct the error (by correcting or cancelling the entry) as provided in section 15 and shall send an extract of the entry showing the error and how it has been corrected to the Administrator or the officer specified by it in this behalf.

(2) In the case referred to in sub-rule (1) if the register is not in his possession, the Registrar shall make a report to the Administrator or the officer specified by him in this behalf and call for relevant register and after enquiring into the matter, if he is satisfied that any such error has been made, make the necessary correction.

(3) Any such correction as mentioned in sub-rule (2) shall be countersigned by the Administrator or the officer specified by him in this behalf when the register is received from the Registrar.

(4) If any person asserts that any entry in the register of births and deaths is erroneous in substance, the Registrar may correct the entry in the manner prescribed under section 15 upon production by that person a declaration setting for the nature of the error and true facts of the case made by two credible persons having knowledge of the facts of the case.

(5) Notwithstanding anything contained in sub-rule (1) and sub-rule (4), the Registrar shall make report of any correction of the kind referred to therein giving necessary details to the Administrator or the officer specified in this behalf.

(6) If it is proved to the satisfaction of the Registrar that any entry in the register of births and deaths has been fraudulently or improperly made, he

shall make a report giving necessary details to the officer authorised by the Chief Registrar by general or special orders in this behalf under section 25 and on hearing from him take necessary action in the matter.

(7) In every case in which an entry is corrected or cancelled under this rule, intimation thereof should be sent to the permanent address of the person who has given information under section 8 or section 9.

13. Form of register under section 16.—(1) The register of births, still births and deaths to be kept by the Registrar under section 16 shall be in three parts as set out in Form Nos. 11, 12 and 13 respectively and in each part of the register, the event shall be numbered serially and for each calendar year.

(2) A new register shall be opened on the first day of January of each year.

(3) An event which occurred in any previous year shall be recorded in the register for the year in which it is reported;

Provided that no entry shall be interpolated between two entries recorded earlier.

14. Fees and postal charges payable under Section 17.—(1) The fees payable for a search to be made or an extract to be issued under section 17 shall be as follows:—

(a) search for a single entry in the first year for which the search is made.	1.00
(b) for every additional year for which the search is continued.	1.00
(c) for granting extract relating to each birth or death.	1.00

(2) Any such extract in regard to a birth or death shall be issued by the Registrar or the officer authorised by the Administrator in this behalf in Form No. 9 or as the case may be, Form No. 10 and shall be certified in the manner provided for in section 76 of the Indian Evidence Act, 1872.

(3) Any such extract may be furnished to the person asking for it by post on payment of the postal charges therefor.

15. Interval and forms of periodical returns under Section 19(1).—(1) Every Registrar, including the Registrar for a Municipality with a population less than 30,000 shall send to the Chief Registrar or the officer specified by him in this behalf on or before the 5th of each month, a true copy of the entries in register of births and deaths relating to the month immediately preceding.

(2) The officer so specified shall forward all such copies of the entries in the register of births and deaths received by him to the Chief Registrar not later than the 10th of that month. He shall also send at the same time a report showing the names of the specified areas within his jurisdiction to which the birth and death entries relate (including those areas where no birth or death has occurred) along with the number of births, still births and deaths registered in each.

(3) The Registrar for a Municipality with a population more than 30,000 shall send to the Chief Re-

gistrar in Form No. 14 a weekly return of births and deaths within 7 days of the expiry of the week to which the information relates, and in Form No. 15 a monthly return of births and deaths by the end of the month following the month to which the information relates.

16. Statistical report under Section 19(2).— The statistical report under sub-section (2) of section 19 shall be in Form No. 16 and shall be completed for each year before the 31st July of the year immediately following and shall be published as soon as may be thereafter but in any case not later than five months from that date.

17. Conditions for compounding offences under Section 23.— (1) Any offence punishable under section 23 may, either before or after the institution of original proceedings under this Act, be compounded by an officer authorised by the Chief Registrar by a general or special order in this behalf, if the officer so authorised is satisfied that the offence was committed through inadvertence or oversight or for the first time ...

(2) Any such offence may be compounded on payment of such sum, not exceeding rupees fifty for offences under sub-section (1), (2) and (3), and rupees ten for offences under sub-section (4), of section 23 as the said officer may think fit.

18. Registers and other records under section 30(2)(k).— (1) The register of births and deaths shall be a record of permanent importance and shall not be destroyed.

(2) All information received by the Registrar under sections 8 and 9 and the certificate as to the cause of deaths furnished under sub-section (3) of section 10 of the Act shall form an integral part of the register of births and deaths and shall not be destroyed.

(3) Every register of births and deaths and the forms relating to the entries therein shall be retained by the Registrar in his possession for a period of twelve months after the end of the calendar year to which it relates and such register and forms shall thereafter be transferred for safe custody to such officer as may be specified by the Administrator in this behalf.

19. All fees payable under the Act may be paid by cash or by money order or postal order.
