Overview

The total Budget Announcements in the Budget Speech 2021-22 delivered by the Hon'ble Chief Minister/Minister for Finance were 252.

111 announcements which include various civil projects/schemes have been implemented during the financial year 2021-22 which is 44% of the total announcements.

The announcements that will be completed during the financial year 2022-23 are 42. This includes various projects which are in the final stages of completion.

The announcements that will be completed after March 2023 are 98. Civil Works on some projects are in progress and in some projects pre-tender activities are going on.
